Effective Monday, 02/25/19, Pathology Laboratories, Inc. (PathLabs) will no longer be performing the Ova/Parasites Exam (Unit Code 80106) in-house. The test is no longer in high-demand as it has been replaced by other state-of-the-art molecular testing.

In its place, PathLabs will offer the test, Ova and Parasites, Single Sample, (Unit Code 39216). This test will be referred to an affiliate laboratory of Sonic Healthcare USA, Inc., Clinical Pathology Laboratories, Inc. (CPL) of Austin, TX.

Since the test offering is a new Unit Code, we are providing relevant information for our clients to share with their EMR vendors as is necessary in case your orders are transmitted to us via a bidirectional interface.

For those sending orders to us via our Atlas internet product, Athena or Practice Fusion, we have already communicated these changes to those relevant vendors, so those databases will be updated for an effective transition.
